**II. PATIENCE AND PAIN ABOVE ALL** 



The Monko universe is filled with different beings that Monko encounters throughout his journey, many of these characters are symbols for experiences and concepts you will encounter on your path to enlightenment.






An Ancient Monk who has experienced true enlightenment by following the path of Monkoism. He guides all Monks on their journey, with his ancient wisdom.
